# COVID-19 Health and Safety Plan Overview for Conducting Classes and Camps during the COVID-19 Pandemic

### (Subject to change as CDC Guidelines and Governmental Orders change)

This COVID-19 Health and Safety Plan was developed to achieve the following goals:

- 1. Identify participants with potential COVID-19 exposure before program group contact.
  - 2. Minimize the potential transmission of COVID-19 amongst program participants.
    - 3. Quickly identify in program COVID-19 exposure and communicate potential intraprogram participant contacts.
- 4. Develop a procedure for program-wide closures, cleaning and re-opening post-positive COVID19 participant test results. Federal and state guidelines used in developing this plan include: 1. CDC Guidelines for summer camp programs (5/15/2020) 2. PRPS (Pennsylvania Recreation and Park Society) (6/3/2020) 3. PA Dept. of Health Guidance (6/10/2020)

Our class will include the following recommended **safety precautions**:

- Reducing overall daily class attendance to comply with current class size regulations.
- Handwashing will be required upon drop off and before parent pickup if possible, if not hand sanitizer will be used. Hand sanitizer will also be used when unintentional physical touching does occur.
  - Social distancing; activities will be done exclusively in the class/camp groups, and with six ft. distance when feasible. Drop-ins will not be allowed.
- Staff and students will be educated about proper hygiene techniques.
- Staff will wear facemasks and face shields each day while working and will use hand sanitizer before and after any transfer of physical items amongst students.
- The entire site(tables&chairs) will be disinfected before and at the end of each program day/class.
- The program will not include field trips or utilize transportation. Communal meals or snacks are not served.
- While we can only be responsible for cleaning and disinfecting the classroom we use, the facilities at which we will conduct camps and classes have assured us that they are regularly disinfecting the facility.
- There will be no food allowed for our weekly 45-60min long classes. Half day and full day camps will eat snack and lunch outside. The only drinks allowed indoors are those in a straw-type container, so that students can drink while inserting the straw under the mask, without removing the mask.
- Staff will wash hands and do temperature checks upon arrival each morning. Those with temperatures above 100.4 will be sent home until cleared in writing by the medical doctor.
- Should a student become ill and unable to attend the weekly classes or camp, we will endeavor to provide options for virtual learning.

Cristina Hartley is the identified Health and Safety Officer and will oversee plan compliance. We cannot control all risks during our camps and classes. Parents will be required to sign a waiver indicating that they are aware of the potential risk of infection when allowing their children to participate in a group setting with other children.

### **Drop off Procedures:**

- 1. Parents/Guardians are asked to either form a car line where possible, and must remain inside their vehicle at all times; or walk their students to the class/camp site. Students' temperature will be checked via infra-red thermometer upon arrival each morning before exiting the car/entering class or camp site. Those with temperatures above 100.4 will be sent home until cleared in writing by the medical doctor.
- 2. Students will then walk inside to the bathroom for handwashing (minimum 20 seconds). If hand washing is not an immediate option, hand sanitizer will be used.
- 3. Students will then head to the classroom.
- 4. Each student will be given individual art supplies (colored pencils, eraser, pencils, markers, individual hand sanitizer bottle etc). There will be NO SHARING OF ART SUPPLIES like in prior classes pre-COVID 19.
  - 5. Each student will use the same individual supplies each class, and take them home at the end of the session.
- 6. Students will be sat 6ft apart as much as possible. Siblings will be sat together.
- 7.We will have disposable face masks available for students to wear during class to comply with current regulations. Students are also welcome to bring their own, if preferred.

#### **Pick up Procedures:**

- 1. Students will wash their hands or use hand sanitizer.
- 2. Students will then retrieve their bags/drawings and head outside/to pick up location.
- 3. Students will get into parent/guardian's vehicle.

# If a student/staff exhibits COVID-19 symptoms:

- 1. Student/staff will be removed from the group.
- 2. Student/staff would be required to wear a facemask until they have left the site.
- 3. Student/staff cannot return to the program until they have received a negative COVID-19 test result.

## If a student/staff tests positive for COVID-19:

- 1. Said student/staff cannot return to the program for 14 days or as established in current CDC documents.

- 2. All other students/staff who came in contact with said student would be notified that someone in their group had tested positive for COVID-19. Names will not be shared. Local health officials would be notified.
- 3. The entire class site will shut down for two days.
  - a. The first day so any potential COVID-19 particles could come to rest.
  - b. The second day so the campsite could be sanitized and disinfected.
- 4. Classes could then resume as normal.
